SOME 125 LYNCHBURG GE EMPLOYEES TO BE AFFECTED BY REDUCTION IN FORCES...

Manufacturing General Manager Winston Stalcup announced this morning that the short-term production requirements which had necessitated the hiring of people last summer and fall were fulfilled by year end, and "as a result, this will necessitate a reduction in forces in both Lynchburg and Florence."

In Lynchburg, some 125 hourly employees will be affected, most of whom were hired in August and September 1981 to meet the increased backlog of orders at that time.

"Announcement of any personnel reduction is always an unpleasant task," said

Winston, "but it is a necessary business decision. All indicators in our economy point toward a difficult period for us throughout the first quarter of 1982 and probably until mid-year.

"Our customers are faced with the same problems facing our own business--inflation, high interest rates and uncertainties as to the length and depth of the current recession--and therefore are holding up on placing orders for our products until they, themselves, can get a clearer picture of what the future holds."

Winston pointed out that for the past five years, MCB's Lynchburg operations

have maintained a fairly level employment total.

"In fact," he said, "we have been able to minimize employment reductions in spite of a very difficult economy. Our goal continues to be maintaining stable, level employment here."

Employees affected are receiving their notices today. All long-standing reduction-in-forces policies will be followed.

"Employees affected may be assured of management's concern for them and of our desire to assist them in any way possible in making an adjustment to lack-of-work status," said Winston.

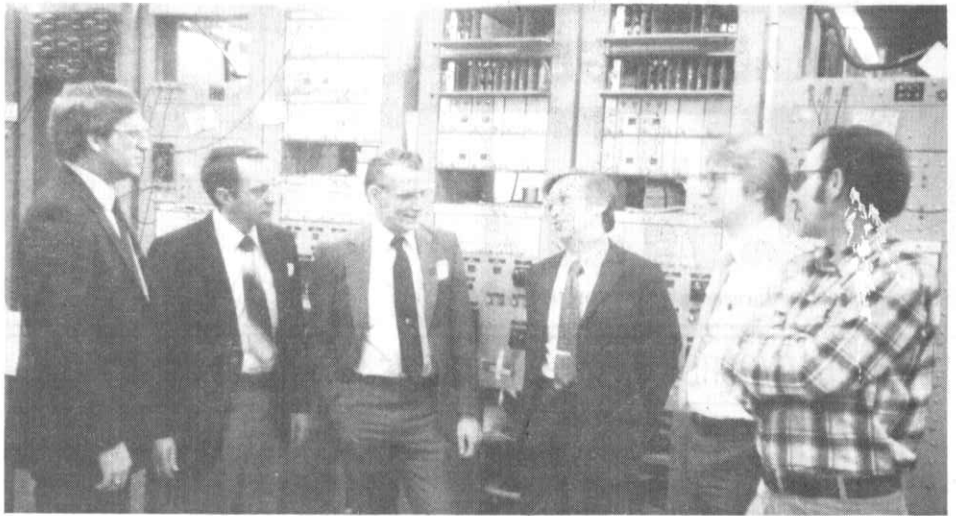

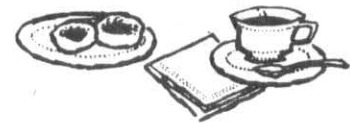
